Example Bank Statement

1. Name of the bank.
2. As this account is not in GBP (£) it needs to be converted to this by using Oanda: [Currency Converter | Foreign Exchange Rates | OANDA](#) on the date of application.
3. If the account is in your parent's name, you will need a consent letter. You cannot use any other person's account as evidence (apart from a partner if they are applying at the same time) or business bank accounts.
4. It is important to have the dates of when the statement is from and to shown on the statement. This may just be shown via the list of transactions.
5. UKVI will use the lowest amount in the account in the relevant 28 day period.
6. You should submit your visa application no later than 31 days from the date of the closing balance on your statement.
